

ENHANCED NON-DISCLOSURE AGREEMENT

(B2C – Strict anonymity)



Between the undersigned:

Louise Jean, trading under the business name Maison Louise Elite™, residing at Rue Paul Lauters 5, 1000 Brussels (Belgium), acting as the service provider,

Hereinafter referred to as the “Service Provider”,

On the one hand,

And:

Mr. / Mrs. _____, Born on the _____, Residing at _____,

Hereinafter referred to as the “Client”,

On the other hand,

The Service Provider and the Client are collectively referred to as the “Parties”.

IT IS HEREBY AGREED AS FOLLOWS:

ARTICLE 1 - PURPOSE & SCOPE OF COMPLICITY

This agreement establishes an absolute obligation of confidentiality and anonymity regarding all communications and companionship relations managed by our Private Concierge service (hereinafter the "Mission"). The Client's anonymity is recognized as the essential and decisive condition of their consent to contract.

ARTICLE 2 - DEFINITION OF CONFIDENTIAL INFORMATION

"Confidential Information" encompasses the Client's formal identity, their existence as a contact of the House, as well as all logistical, geographical, temporal, or private details related to the Mission.

ARTICLE 3 - OBLIGATIONS & DISCREET COMMITMENT

The Provider binds themselves, for life and without time limitation, to maintain the strictest secrecy. This information shall never be used for commercial communications, portfolios, or advertising. The restricted staff and trusted partners of the House are bound by written agreements to the exact same standards of confidentiality.

ARTICLE 4 - PERPETUITY

The obligation of confidentiality and anonymity is perpetual. It survives the completion of the Mission, as well as the legal or physical dissolution of either Party.

ARTICLE 5 - LEGAL RESERVE

The obligation of confidentiality shall only yield if the Provider is legally compelled by a competent judicial authority (official subpoena). In such circumstances, disclosure will be restricted to the strict minimum and the Client will be immediately informed, if legally permitted.

ARTICLE 6 - PENAL CLAUSE & CIVIL LIABILITY

Any proven breach of anonymity by the Provider immediately engages their civil liability. The Parties expressly agree that in the event of a violation, the Provider shall pay the Client, as a fixed and non-reducible penal clause, the sum of **fifteen thousand euros (€15,000 / CHF 15,000)**, without prejudice to further legal remedies.

ARTICLE 7 - JURISDICTION

This agreement is governed by the law of the location where the Mission is executed (Competent courts of Brussels or Geneva, depending on the chosen port of call). The French version remains authoritative in court.
